




Clinical Evidence





SUZIE, 17-YEAR-OLD | SCHOLAR

(Primary/spasmodic dysmenorrhea)



Medical history: menarche at age 14, no abnormal findings on pelvic examination or imaging studies (i.e. ultrasonography).

Present disorders: Severe spasmodic pains during menstruation that started soon after menarche. The pains last between 48 and 72 hours. The pain is associated with nausea and vomiting. In addition, she feels dizzy and suffers from headaches during this time.

Non-steroidal anti-inflammatories and opioid analgesics do help relieve the pain but leaves her feeling extremely tired. She would like to explore other options rather than a high dose combination oral contraceptive suggested by her family doctor.




